## **New Resolutions This Week at Ohio** State Board of Ed on Title IX Gender Controversy



The Ohio State Board of Education will take up several resolutions on Monday, November 14 starting at 8:00 am., again considering whether to object (or not) to the radical, gender- deceptive federal proposed changes to Title IX law. There will be no public testimony this day, but your attendance will help show a strong pro-family presence (25 S. Front Street, Columbus 43215). On Tuesday, Nov. 15, depending on the outcome of Monday's deliberations, there may be public testimony on these resolutions. If you want to testify, email SBOE@education.ohio.gov .

### **HB 454 Hearing** Wednesday, **November 16 and Possible Vote**

On Wednesday, November 16 at 10:00 a.m. the House Committee on Families, Aging and Human Services will hold a 5th hearing on HB 454, the SAFE act (Save Adolescents from Experimentation), the bill to ban medical treatment on minors for the harmful purpose of allegedly changing gender. It will be held in Room 122 in the Statehouse with a possible vote. Although this is "opponent" testimony, your presence would send a good message to committee members. There will be a lot of opposition to this bill. Also, call the Speaker of the House, Bob Cupp, and ask him to bring this bill to the House floor for a vote as soon as possible: (614) 466-9624 And <u>CONTACT</u> the Senate Majority Leader, Matt Huffman, and ask that he bring this before the Senate for a vote as soon as possible.
